**Public Service Stability Agreement 2013 – 2018 (Haddington Road Agreement/  
Lansdowne Road Agreement)**

**Revision of Teacher Salaries with effect from 1 September 2017**

1. The purpose of this Circular is to notify Managerial Authorities and teachers of a pay increase for teachers with effect from 1 September 2017, arising from the Public Service Stability Agreement 2013 – 2018 (Haddington Road Agreement/ Lansdowne Road Agreement).

**Inclusion of S&S Moiety in the Teacher Pay Scales with effect from 1 September 2017**

2. Under the Haddington Road Agreement and as stated in [Circular 0006/2014](#), participation in the Supervision and Substitution scheme is compulsory for all teachers, save for those who availed of the opt-out arrangement.
3. A gross additional payment of €1,592 is to be included in the Common Basic Scale for teachers in two moieties. The first moiety was included in the scale on 1 September 2016. Under this Circular, the second moiety of €796 will be included in the scale from 1 September 2017.
4. Increased pay scales for post-primary teachers, to apply with effect from 1 September 2017 and which include the €796 moiety, are attached at Appendix 1. Increased hourly part-time rates for post-primary teachers which take effect from 1 September 2017 are attached at Appendix 2.
5. All salary scales and hourly casual and non-casual rates payable to post-primary teachers set out in previous Circulars are superseded by the terms of this Circular with effect from 1 September 2017.
